#### Abstract

The relationship between parliaments and governments during the Covid19 pandemic has been widely examined by various disciplines, typically analysing data on the laws and procedures enforced to manage the emergency. This literature generally agrees that the government dominated the management of the pandemic at the expense of parliamentary prerogatives. However, such data may be scarcely refined to fully grasp some nuances. Above all, they may give little information on the factors that influenced the balance of powers between the two institutions. This article focuses on the Italian case complementing data on legislation with semi-structured interviews with Members of the Parliament and the Government, as well as high-ranking bureaucrats, to gain a more in-depth understanding of these processes. The data on legislation suggests that the government dominance was strong at every stage of the emergency, yet parliament slightly regained some prerogatives over time. This process began under Prime Minister Giuseppe Conte but became more pronounced under Mario Draghi.

However, in our interviews the perceptions of a continuity between the two prime ministers prevail. The acquisition of knowledge on the pandemic has been perceived by several interviews as a factor that helped parliament in regaining some oversight, which makes it a possible outcome of a policy learning process. However, other factors emerge with a certain importance, such as the long-term weakening of the Italian parliament and the direct role of prime ministers in strengthening the role of the executive, especially during Draghi's tenure.

# - Piccolino, G., Puleo, L. Exploring the Patterns of Competition among 'Mirror Parties': a General Framework Tested on Fratelli d'Italia and Lega. Swiss Political Science Review (In Revise and Resubmit)

#### **Abstract**

While competition among parties belonging to the same party family is widespread, the literature has shown little attention to investigating its patterns. We aim to outline possible patterns of competition among these actors, which we label as 'mirror parties', by testing a novel framework. We expect these parties to show a similar salience on their core issues, while differentiating their supply on non-core ones. Such dynamics are explored for the mutual attacks between party leaders. This framework is tested on the competition between Fratelli d'Italia and Lega in the 2018 and 2022 electoral campaigns. In line with our expectations, these parties showed a similar salience on core issues (migration and law and order), while more marked differences on non-core ones. Studying the attacks between leaders, competition developed along non-core issues. Finally, we also considered patterns of competition on populism, though a new method to quantify its presence across policy domains.

# - Piccolino, G., Marini, S. Twenty Thousand Leagues below the Po: Analysing Career Patterns of the Lega (Nord) Representatives. Contemporary Italian Politics (under review)

#### **Abstract**

The Lega (Nord) has gone through the significant transformations of the Italian political system over the past four decades, with various ideological shifts and phases of electoral success. We focus on exploring an understudied feature of this party: the career patterns of its representatives — Members of Parliament (MPs) and Regional Councillors (RCs) — and particularly their prior experiences in public office. This analysis reveals how these patterns have become consolidated over time along a specific trajectory, as most MPs/RCs have reached these positions after having previously held offices for the Lega. However, along the nationalisation strategy adopted by Salvini, a clear discrepancy emerges.

Elected representatives in Northern regions continue to have a consistent electoral history within the party. In Southern regions, the party has instead made an endemic use of party-switchers, who form the core of its representatives in these areas. In other words, different career patterns coexist within the same party.
